How do I establish legal ownership for unregistered land?

Guidance on establishing legal ownership for unregistered land using historical title deeds and navigating the process for a secure, official registration. Unregistered land is property where ownership has not been recorded in the government's central property register.

What is unregistered land?

Unregistered land is property where ownership has not been recorded in the government's central property register. This is different from registered land, where HM Land Registry holds a digital record of ownership. A significant portion of land remains unregistered, often because it has not been sold or mortgaged in many decades.

Why should you register land?

Registering land means that necessary title documents will be centrally held by the Land Registry. This negates the need for original title deeds to be kept safely and mitigates the risk of loss or damage. When dealing with registered land and property, the sale or funding process is much simpler and quicker than dealing with unregistered property.

How do I know if a land is unregistered?

A negative result from the search indicates the land is likely unregistered, and to be certain, you can apply for an official search of the index map using Form SIM to confirm the land's status. For unregistered land, ownership is proven through a collection of physical papers known as title deeds.

Is registering unregistered land a defect in ownership?

Owning unregistered land is not a defect in ownership, and the process of registering it for the first time provides greater clarity and security. The definitive source for property registration information is HM Land Registry, which covers England and Wales.

Where is registered land filed?

Registered land is filed in the Land Court's registered land districts housed within the county Registries of Deeds. Deeds to eighty to ninety per cent of the properties in the Commonwealth are filed as recorded land. Registers of Deeds stamp each recorded document with a book and page number, and the documents are available online.
