What is the electricity storage policy framework for Ireland?

In line with CAP Action EL/24/16, the Electricity Storage Policy Framework for Ireland (ESPF) was published by my Department in July 2024. The policy framework included 10 Government actions to support the role of electricity storage systems in Ireland's energy transition.

What is Ireland's energy transition policy framework?

The policy framework included 10 Government actions to support the role of electricity storage systems in Ireland's energy transition. Actions #6 to #10 of the policy framework are designed to stimulate the development of the optimum level of electricity storage systems, including Long Duration Electricity Storage on to the grid network by 2040.

What is energy storage Ireland?

Energy Storage Ireland is a representative association of public and private sector organisations who are interested and active in the development of energy storage in Ireland and Northern Ireland. Delivering the energy storage technologies to enable a secure, carbon free electricity system on the island of Ireland by 2035.

What is Ireland doing about energy cost competitiveness?

Ireland has committed to developing metrics of energy cost competitiveness as outlined in the Government's White Paper on Ireland's Transition to a Low Carbon Energy Future 2015-2030. We have developed average electricity and natural gas prices for business and households. These are based on the EU Electricity and Gas Price Regulation statistics.

What is EirGrid's long duration energy storage (LDEs) procurement mechanism?

In line with Action #6, EirGrid, in conjunction with the Regulatory Authority, are developing a procurement mechanism for long-duration electricity storage, through their Long Duration Energy Storage (LDES) product. The LDES product is in its initial stages with 2 separate public consultations expected in 2025 and 2026.

Does gas affect electricity prices in Ireland?

As gas is the largest and the marginal fuel input to electricity generation in Ireland, the price of gas directly affects the price of electricity. However, the full volatility of international commodity gas prices is not reflected in domestic prices because infrastructure costs and levies remain the same, irrespective.
