How much will Italy spend on agripv projects in 2024?

Boosted by a 163% year-on-year growth for utility-scale solar, Italy added 6.8GW of PV in 2024. Held by Italy's energy management agency Gestore dei Servizi Energetici (GSE), the tender will allocate EUR323 million to fund agriPV projects.

How many solar project proposals are there in Italy?

From pv magazine Italy The first solar energy auction under Italy's new incentive scheme for renewable energy, the "transitional" FER X program, has attracted 1,387 project proposals with a combined capacity of 17,537 MW, according to Italian energy agency GSE. Prequalified project developers have until Sept. 12 to submit final offers.

How much agrivoltaic capacity will Italy invest in 2026?

Under the decree, Italy plans to award a total of EUR1.7 billion to support commercial operations of at least 1.04 GW of new agrivoltaic capacity by June 30, 2026 (see Italy Publishes Decree For Agrivoltaic Deployment). While the previous round exceeded the capacity tendered, the funds were not exhausted.

The construction deadline for Italy's 1.5 GW agrivoltaics tender was extended to June 2026, with projects awarded to European Energy, Solarig, DCH, and others.
